3.	Timeframes must be strictly adhered to.
4.	Counsel need not repeat the content of the papers or their heads of argument. Counsel must reduce their arguments to the essence of the case.
5.	Counsel must hand up an authorities bundle at the commencement of argument. Authority bundles need to be properly marked with the <i>case number, parties</i> and identified as either <i>applicant's bundle</i> or <i>respondent's bundle</i> . Only cases upon which a particular party will place special reliance must be contained in the authority bundles.
