1. **Kindly be advised that the proceedings for Tuesday, 29 October 2024 will be in open court.** Please consult the day roll for the court room number to be used. Court will commence at 10H00 and introductions may be done at 09H45 (room 3.6).
2. **A notice regarding the proceedings on Thursday, 31 October 2024 will be made available in due course.**
3. A Practice Note comprehensively indicating the issues to be decided upon in the matter must be uploaded on Caseline as well as to be emailed to the email address below by no later than 12h00 on Monday 28 October 2024, for matters to be heard on Tuesday 29 October 2024 and no later than 12h00 on Wednesday 30 October 2024 for matters to be heard on Thursday 31 October 2024. Failure to file a comprehensive Practice Note will result in the matter being struck off the roll.
4. **The Practise Note must contain detailed contacts particulars** (Cell numbers and email addresses of the person appearing) In the event that the person instructed changes an additional updated Practice Note must again be filed.
5. A proposed Draft Order, in word format, must be uploaded under a newly created section on Caseline with the heading Draft Order and the date of hearing. Any and all attachments to the proposed Draft Order must be filed thereunder as well. The proposed Draft Order must contain the Judge's Name, correct date, correct case number and correctly spelled



parties. **A printed copy of the proposed Draft Order and any attachments thereto must be handed up in court.**

6. No further documents are to be uploaded after the cut-off time indicated in the practice manual as read with the practice directive of this court unless with the express permission of the Honourable Judge Khumalo. Non-Compliance will result in the matter being removed from the roll due to papers not being in order.
