URGENT COURT DIRECTIVE: 25 - 29 NOVEMBER 2024
BEFORE JUSTICE WANLESS J**

Parties shall attend court with 1 hard copy of their **Heads of Argument, List of Authorities** (if any) and **1 Copy of the proposed Draft order** depicting the details of the court room (Court 4A); the Judge presiding over the matter (Wanless J).
