DIRECTIVE IN RESPECT FOR OPPOSED & UNOPPOSED FAMILY COURT MATTERS

- All unopposed family court matters will proceed in open court (TBA)
- Proceedings will start at 10:00 on Monday. Starting with removals, postponements & settlements. Thereafter, the roll will proceed according to seniority of Counsel.
- Plaintiffs in unopposed divorce matters are as a general rule not required to appear in person in which case an uploaded evidence affidavit will suffice. However, should no evidence affidavit be uploaded the plaintiff must be ready to testify.
- All parties testifying **must** be suitably dressed.
- Any settlement agreements where minor children are involved must already have been endorsed by the Family Advocate and must be marked "Annexure A".
- Parties must ensure that a case profile is created for their matters on Caselines and relevant documents must be uploaded before 12h00 on 29 November 2024. No further papers will be considered after Friday, 29 November 2024 at 12h00, nor documents are to be uploaded without the Judge's leave.
- Practice Notes are to be filed by no later than Friday, 29 November 2024, 12h00.
- Counsel is advised to bring one copy of the court order and the settlement agreement where applicable indicating the number on the roll, the date of hearing and the name of the Judge (Oosthuizen-Senekal AJ). Same must be uploaded on Caselines.
