Should it not be possible to file a joint practice note, parties who are appearing should file a practice note dealing with all aspects referred to in paragraph 25.17 of the Judge President's Directive and indicate the estimated time required to argue the matter.
8. Parties are requested to confirm the preferred mode of hearing and to indicate if there has been any agreement reached in this regard.
