- III. IF ANY MATTER SETTLES OR WILL NOT BE PROCEEDED WITH, THE SECRETARY OF BOTSI-THULARE AJ MUST BE INFORMED THEREOF IMMEDIATELY UPON IT BECOMING CLEAR THAT THE MATTER HAS BEEN SETTLED OR WILL NOT BE PROCEEDED WITH. FAILURE TO DO SO MAY ATTRACT PUNITIVE COSTS ORDERS.
