Directives:

1. All unopposed applications will be heard on **Monday, 12 May 2025 at 10h00.**
2. **ALL documents in all matters must be uploaded to the CaseLines digital platform,** including in instances where it is a Court Online matter. A matter which is non-compliant with this requirement runs the risk of being struck off. **Only matters that have been uploaded on CaseLines will be heard.**

- Litigants who struggle with bundling their files from Court Online to CaseLines are to follow the attached 7 step user manual. Alternatively, contact the help desk using the information below:

3. The hearings will be conducted in open court unless otherwise advised.
4. Introductions in chambers will not be necessary.
5. The Judge invites all practitioners to indicate, should they so wish, by which pronouns they wish to be addressed.
6. All documents, heads of argument and practice notes must be accessible on CaseLines. If not, practitioners risk their matters being struck off the roll.
7. The annexures of affidavits must be uploaded and identified separately.
8. Updated practice notes and draft orders must be uploaded on CaseLines in accordance with the practice directives of this Division.

9. The Judge may communicate with the parties' representatives via widely shared notes posted on the electronic file. Legal representatives are to look out for these communications and are requested to respond to such communications.
10. The bundle freeze date is set for **Friday, 8 May 2025 at 09h00**.
11. Matters in which practitioners fail to upload a practice note timeously risk being removed or struck from the roll. Practice notes and draft orders sent by email will not be accepted. They must be accessible on CaseLines and uploaded within the stipulated timeframe.
12. Practitioners are reminded to remain available in case their matter is called earlier than appears on the roll below.
13. Parties are to notify our office in writing of any removal, postponements or settlements forthwith.
14. Proposed draft orders should be emailed to judge's registrar in word version (name of the parties and case number) in the subject line. Please ensure that the Judge's name, **F Bezuidenhout** appears at the top and the details of the counsel appears at the bottom of the order. The court heading must read "**Gauteng Division, Johannesburg**".
