1. Applications will be heard on the dates and times indicated below.

A matter which is non-compliant with this requirement runs the risk of being struck off. **Only matters that have been uploaded on CaseLines will be heard.**

6. If a matter becomes settled or the parties agree to postpone, the Judge's Registrar is to be informed in writing without delay.
7. Practitioners are reminded to remain available in case their matter is called earlier than appears on the roll below.
8. The Judge may communicate with the parties' representatives via widely shared notes posted on the electronic file. Legal representatives are to look out for these communications and are requested to respond to such communications.

9. Joint Practice notes are to be filed by **Friday, 9 May 2024 at 10h00**.
  
10. Proposed draft orders should be emailed to judge’s registrar in word version (name of the parties and case number) in the subject line. Please ensure that the Judge’s name, **F Bezuidenhout** appears at the top and the details of the counsel appears at the bottom of the order. The court heading must read “**Gauteng Division, Johannesburg**”.
