1. All the trial interlocutory matters on the roll before Acting Judge Carrim will be heard in open court at 10:00;
2. Removals, postponements and settlements will be called first, thereafter the matters will be dealt with numerically;
3. If counsel is not in court when their matter is called it will be struck from the roll;
4. One copy of the draft order/order should be handed up in court;
5. **The parties must ensure that the order handed up in court has the correct case number, parties, ID numbers (where applicable) and the correct prayers prayed for included, as no order will be amended after it has been granted in court;**
6. Do not e-mail any documents or draft orders;
7. The papers should be in order and on Caselines. No matter will stand down to later in the week;
8. The order made in court will be signed and stamped by the Registrar and uploaded onto Caselines within 7 court days;
9. **Legal Practitioners do not have to introduce themselves to the Judge in chambers, they may introduce themselves in court when their matter is called.**
