2. **THE DEFAULT POSITION IS A PHYSICAL HEARING. THE COURT ROOM WILL BE ADVISED AS SOON AS POSSIBLE.**
3. Introductions in chambers are not necessary.
4. Proposed draft orders should be emailed to judge's registrar in word version (name of the parties and case number) in the subject line. Please ensure that the Judge's name, **F Bezuidenhout** appears at the top and the details of the counsel appears at the bottom of the order. The court heading must read "**Gauteng Division, Johannesburg**".
5. All papers, heads of argument and practice notes must be filed by no later than **Monday, 12 May 2025 at 09h00**. The annexures of affidavits must be uploaded and identified separately.
6. **ALL documents in all matters must be uploaded to the CaseLines digital platform**, including in instances where it is a Court Online matter. A matter which is non-compliant with this requirement runs the risk of being struck off. **Only matters that have been uploaded on CaseLines will be heard.**
